Memorial Day in Oregon

On Monday, May 27th the Col. Edward D. Baker Camp and Co. B, 71st Pennsylvania Volunteer Infantry, SVR participated in our annual Memorial Day event at the Eugene Pioneer Cemetery.

This event was conducted with the Lane County Veterans of Foreign Wars . Thirteen members were in attendance. Baker Camp Commander DH Shearer gave the invocation and also read the Letter from General John L. Logan (Commander - Grand Army of the Republic) that officially created Memorial Day. The SVR firing detail was led by Captain Mark Stevens and 1st Sgt. Tony Pasillas. This group included Pvt. Dean Long, Pvt. Gary Wolfson, Pvt. Phil McQueen, and Corporals Tim O'Neal and James Anello. The Color Guard included Color Sergeant Mark Hagedorn, Pvt. James Harnish and Cadet Chase Stoddard.

Baker Camp member Stephen Holgate presented the Gettysburg Address as President Lincoln. Captain Steve Betschart (Co. B Commander) and DH Shearer closed the program with echo Taps.

After the VFW program, members gathered at the headstone of former commander Harold Slavik to conduct an induction ceremony for those who had not yet taken the SUVCW oath. Cadet Chase Stoddard, James Harnish and Dean Long all gave their pledge to the Sons of Union Veterans (administered by Camp Commander DH Shearer) and received their medals.

North Texas Memorial Day

Historic Pecan Grove Cemetery in McKinney, Texas, celebrated a traditional Memorial Day Ceremony on the grounds of the cemetery.

At 8:00 AM, prior to the main program, Camp 18 in conjunction with Co. K, 1st US Infantry, SVR and friends from the North Texas Reenactment Society conducted a separate memorial service for Civil War veterans. Brother Paul Ridenour, PCC, acted as chaplain and gave the invocation. Camp 18 Commander, Rick Erder presented a reading from Oliver Wendell Holmes Jr. Brother Chuck Sprague, PDC, Read the roll of honor of the union veterans interred and Commander Erder placed a wreath for the union veterans on the Boyd monument. Brother Bryan Powers commanded the firing party that fired three volleys in honor of the veterans. The firing party consisted of Brother Don Gates, PDC, Brother John Eger, along with Robert Mathis and Robert Burrage of the North Texas Reenactment Society. After completing the service for union veterans, the firing party and colors marched to the confederate monument erected by the Wells camp of the Sons of Confederate Veterans. Sergeant Mathis read the inscription from the confederate monument in Arlington National Cemetery and Brother Ridenour, PCC, read the closing prayer. Flags with silk flowers were then placed on the graves of the union veterans and a flag with a wreath was placed on the grave of past Camp 18 member William Fleming, a Vietnam Veteran.

The main program began at 10:00 AM and consisted of a ringing of the church bell, a presentation of colors, speeches, a rider less horse, calling of the roll of honor, volley firing, taps, retreat of colors and a fly by with a UH-1 Iroquois (Huey) helicopter. Camp 18, Co. K, 1st US Infantry, SVR and friends from the North Texas Reenactment Society participated in the main program by providing a color guard and firing party.
